1. Introduction

This guide will give you a complete overview of our PBSeasy® platforms

- MyPBSeasy®
- PBSeasy[®] Shop

Links to our platforms:

2. Login details

You will receive your login details from our support team. Your login consists of your username (valid email address) and a password.

To change the password for **MyPBSeasy® and the PBSeasy® Shop** please log into either site. The password, once changed, will be valid for both pages.

You have the option of changing your password:

- MyPBSeasy[®] → Users
- PBSeasy[®] shop platform → account → profile.

NOTE: as both sites are connected, you only need to change your password on one site.

• Ticket system

The ticket system is an independent platform. A password change is only valid for this site. Open the page via the respective link and click on your user icon on the top right-hand side. Select "Profile" \rightarrow "Change Password".

3. MyPBSeasy®

MyPBSeasy[®] is your backoffice platform in our system, which affords you complete control over your buyer/supplier relations.

The number of tabs available in MyPBSeasy[®] depend on various factors like booked products and individual user rights.

For example: if you use the Excel template to upload your product data, additional tabs "Media" and "Catalog" will be displayed.

This guide lists and explains every tab currently available in MyPBSeasy®.



Order Tracker

The Ordertracker allows you to view the complete PBSeasy[®] order history. It lists all orders placed by your retailers via PBSeasy[®] and offers you search and resend options.

Ordertracker options:

- Search by date, retailer/buyer name or GLN, order number or order channel. Searching by "Severity" brings up all orders containing errors. Orders containing errors are not sent to you, orders containing warnings are. Retailers are informed if their order contains errors or warnings.
- Resend orders. Use this if you had problems receiving orders to the specified order recipient (e.g., a server failure). Alternatively, you can mark and resend all accumulated orders once the problem is fixed. If the recipient problem persists you can switch to an alternative order recipient (go to "Settings" → "Order transmission") and then command to resend the respective orders.

- View order details: select an order to see a detailed view of your order and follow-on documents (if applicable). The following options are available:
 - Order: View the complete order
 - o Orderlines: view the list of products contained in the order
 - All documents: suppliers who also send follow-on documents, e.g. order response, delivery advise, invoice) through PBSeasy[®], can view these here.
 - Status list: view the different order process stages in PBSeasy[®]. Click on "Dokument anzeigen".
 - Status: 050_INCOMING: original order as received from the buyer
 - 450_EMAIL: PBSeasy[®] order confirmation sent to the buyer
 - 800_SUBMIT: Order transmitted from PBSeasy[®] to supplier

Price Tracker

The Price Tracker lists all net prices (negotiated dealer prices) you sent to your respective retailers. You can export the search result as well as resend the listed net price files.

To use the Price Tracker, your user must have admin rights. For extra security, you need to communicate your IP address to PBS. It will be added to your supplier profile. If you would like to use the Price Tracker, please send an email to support@pbsnetwork.eu.

NOTE: the Price Tracker can only be used if you have a fixed (not dynamic) IP address.

View price file content:

Select respective price file. The tab "Overview" gives you the dates and retailer details for this price file.

- PBSeasy[®] products for buyer Explanation:
 - **PBSeasy® Online**: buyer orders via the PBSeasy® shop platform only
 - PBSeasy[®] mail and PBSeasy[®] direct: buyers are connected to PBSeasy[®] with their ERP system. The only difference consists in the format this buyer is sending their orders in. Mail = ASCII format | Direct = Edifact format
 - PBSeasy® media Shop: buyer can download media files via MyPBSeasy®
 - **PBSeasy® media Push:** buyer receives media files (media assortment) in full as well as updates in BMECAT format with image links.
 - PBSeasy® EDIFAX: suppliers can be sent fax orders to be transferred into EDI orders
 - **PBSeasy® EDI**: transfer orders via EDI (let us know if you are interested in booking this product)
 - Freight group: you can assign a corresponding freight group to each buyer (refer to chapter "Settings" → "Delivery settings" to learn how to set up a freight group profile).
 - **Created date**: date you granted or blocked a buyer in PBSeasy[®]. Switch to status "requested" to see if there are buyers still waiting for your approval.
 - o Granted assortments: applicable if supplier has more than one assortment
 - Additional requested assortments: applicable if supplier has more than one assortment
 - **Media Shop AGB confirmed**: buyer is using the media shop or media push option. Terms and conditions must be acknowledged separately for media files.

Maintain Buyers

Set a check mark to select multiple buyers. You can now export the buyers as a CSV file, send a message via PBSeasy[®] to these buyers or add a freight group for the buyer group.

Assortment files are named for example with the date assortment code_new.96a.zip.

Files marked with "new" mark that is a complete assortment.

Files marked with "u" signify that this is an update. Select "Show updates" to see the update history.

Your buyers can set a check mark and click "request data" to resend your complete assortment or updates to their system once more.

Media Shop

If you maintain a media assortment, which is separate to a data order assortment, it will be displayed to your buyers in this tab.

All connected buyers can obtain free access to our free media database and use it to obtain media data of products by copy & paste or by downloading (max. 50 products per download). Buyer can only see your media assortment if you grant them access to it

Initially the terms and conditions have to be confirmed. After following the process and logging into MyPBSeasy® again all available media assortment(s) can be selected and products files downloaded.



The same procedure applies to terms of use for the eCl@ss classification data. These must be confirmed separately if you want to use this part of the media data.

User

If you want to give more colleagues access to the PBSeasy[®] platform, you have the following options to manage your users accounts.

Create additional user accounts and assign various access rights to these accounts. NOTE: the username must be a **valid email address**.

In the first step, the user profile is created by clicking on + New user

Select "Shop approval" to select the assortments this user should see on the **shop platform**. Default is set to "all granted assortments".

You can furthermore set the following user rights:

- Show product: view products only
- Show prices: products are displayed with price
- Add to shopping cart: if check mark is not set, the shopping cart button will be greyed out. No products can be put in the shopping car
- Place order: if check mark is not set, the user cannot place orders through the shop page.

Delete User

Open the corresponding user by clicking on the username (email address) – select "Delete user".

Change Password

Open corresponding user by clicking on the username (email address) – select "change password".

Settings

In the settings tab you have various options like viewing/amending your company or contact data or upload freight conditions. If you have any questions regarding the settings options, please raise a ticket via the "Ticketsystem" button on top of the page or contact our support team (support@pbsnetwork.eu)

Company settings

- **Company data**: General company information.
- **Contact**: Contact information displayed in the PBSeasy[®] Shop platform in your supplier profile.

Order flow settings

- Order transmission: states how and in which format orders are transmitted to you.
- Error tolerance: If activated and set to e.g. %100 and number of positions o you would accept all orders, even if they contain validation errors.
- Edifact settings: mark/unmark your settings for EDIFACT orders.

Price settings

Receive confirmation that the **net** price file you sent was forwarded to the respective recipient.

• **Price data settings**: mark and input a recipient email address if you would like to receive a APERAK (Application error and acknowledgement) message when sending net prices.

Delivery settings

• Freight conditions

To state your freight conditions, you have the options in MyPBSeasy® listed below. Among the options are to state a minimum order amount (retailers cannot place orders below this order value) as well as two amount brackets for which you can define surcharges. You can set up numerous profiles and link them to respective buyers (in the buyer tab).

Press the button "+new freight condition" to set up a new freight condition profile.

You have the following options:

- **Freight group name**: The very first freight conditions template will always be named "Default". Additional freight groups can be named by you individually.
- **Country:** State the country this freight conditions group is valid for.
- **Currency:** State the respective currency.
- **Minimum order amount:** Orders below the minimum order value cannot be placed through the shop platform (button in shopping cart is greyed out).
- **Amount limit:** State an order amount below which the surcharge, stated in the next field, will apply.
- **Quantity limit surcharge:** Surcharge if order is below the amount limit.
- Amount limit for freight surcharge: specify amount (see screenshot) and the respective surcharge in the next field.
- Freight Surcharge
- Order surcharge: Fixed surcharge amount per order, independent of the order value
- Order line surcharge: Fixed surcharge amount per order line

Additional product settings

- Individual products: a product set up as an "individual" product will not be visible on the shop platform and cannot be found by using the search option in the shop. These products are meant for specific buyers and are not part of a catalog. Once set up, you can communicate the product number or GTIN (EAN) of a product to said buyer. He/she can order them via the Quick order option in the shop or out of their ERP system if their ERP system is connected to PBSeasy[®].
- **Quantity amendment:** is used for buyers ordering directly out of their ERP system. This option applies if a buyer regularly sends the wrong unit/quantity for a specific product. You can set up an exception for this buyer and product, stating what the correct unit/quantity should be.

Example: Product "123456 Pen" is sold by you in a pack of 10 pens per pack.

A buyer orders 20 pens. In their ERP system, the buyer has set this pen as an individual product (because they sell them on as single items), but you only sell these pens as 10 pens per pack. You can state here that if this buyer orders this specific product, you will change the order from 20 pcs to 2 PK (pack) > thus receiving the order with the correct unit instead of erroneously sending out 20 PKs to this customer.

Two additional tabs are available in the tab list if you upload your product data via Excel template:

- **Catalog**: upload your product template and view already uploaded items.
- Media: upload the respective media files (single or zip upload) here.

Catalog (product file upload)

Under this tab you can maintain your assortment(s). You can upload, update, or delete your products via the Excel template. You also have the option of viewing the content of your uploaded items.

The template is divided in mandatory and optional fields, and we encourage you to provide as much details as you can. The richer the content of your product, the better the chances that your products will be selected for order.

If you entered **media file names** in your upload template for example "**testimage.jpg**", you need to upload the physical media files here. Your media files need to have the <u>exact same</u> image names as stated in the template!

Only two image types are **mandatory**.

- P-0401 main product image
- P-0408 -brand logo (JPG, PNG, EPS, SVG)

TIP: If you upload via the Media tab, we recommend uploading the images first. **Advantage**: you would not get a warning when uploading the Excel template stating that images are still missing.

NOTE: the image upload can take some minutes depending on the file sizes. Also, the images are not uploaded synchronically. It is therefore possible, that the images are uploaded but not visible on the page right away.

Validation Protocols

After successfully uploading your data file via MyPBSeasy[®], you will receive an automated email containing up to 3 zip files. All uploads are validated by our central data server, to make sure that our schema criteria are met.

- Processing protocol: states a data processing overview of your uploaded document/media
- **Delta protocol:** states all changes to previously uploaded data.
- **Error Protocol**: will give you more details if there were validation errors. Error protocols always show the error of all products contained in your assortment., not only for the most recent upload.

The most important file is the "Error Protocol".

This protocol gives you details regarding corrections and changes that need to be made to some of your product information.

It distinguishes between Errors and Warnings.

Warnings: GTIN is distributed to our platforms.

Errors: GTINs are not distributed to our platform. You need to fix the error and upload again.

It states that your upload to our server was successful, but that some articles failed the validation process.

In this example, our test assortment contains a base product with errors. Once I correct the base product, the error message for the related article will also disappear.

The warning concerns a missing image. Once I upload the image the warning message will disappear.

All GTINs needing correction are listed in the protocol - also for older uploads. Observe the "modified" field to see when the respective product was uploaded and refer to this upload template should the product not be contained in your most recent upload.

5. Net Prices – negotiated dealer prices

In the logic of our platform, a supplier can have negotiated net prices with each dealer or dealer group they work with.

IMPORTANT: these net prices are <u>not</u> uploaded via the master data feed (product data). You would send these prices separately for each respective buyer.

Why do we have an extra feed for the net prices?

Because these net prices are highly confidential, we don't mix them with the master data feed (list and sales prices).

We have two ways of how you can provide your net prices:

- Via CSV file
- Via PRICAT file

NOTE: In both cases we will provide templates. Kindly contact us (support@pbsnetwork.eu) if you have any questions regarding net prices. The way you provide net prices needs to be set up by us in your supplier profile.

Future prices:

You have the option of sending prices with a future validity date. You can indicate the starting date of your net price for a specific product.

You can also have multiple starting dates. Please note that you must have one separate file per starting date because duplicate EAN codes in one price file are not allowed.

6. PBSeasy[®] Shop Platform

Every supplier gets access to our shop platform. Here you can check how your assortment is displayed to your buyers. It is the best way to see if your product upload has worked correctly.

NOTE: There might be a slight delay between upload and display in the shop, as we validate all incoming product files against our PBSeasy[®] date specifications.

Place test order

This allows you to test the entire order process chain (order entry, further processing, creation of follow-up documents if applicable) yourself and make necessary adjustments.

As a supplier, how can I give dealers access to my assortment(s)?	Registered buyers can apply for assortments via MyPBSeasy®. You are informed via email. To grant or deny access please go to MyPBSeasy® > Buyers > Select the status "requested" in the "Status" column to see buyers applying for your assortment. Select the respective buyer and click on "Activation". Select status "Grant Buyer or Block buyer. When blocking a buyer simply click on "Save". When granting a buyer select the



	respective assortment and, if applicable, the freight group and press "Save".
What is PBSeasy Data?	Suppliers can maintain product data, media data and price files (negotiated dealer prices via PBSeasy®. To guarantee the highest data quality, it is checked against more than 380 criteria (minimum requirements).
How to update product data	There are various ways to update assortments. Either via Datamanager, AMP platform or Excel upload template.
What is the cost of PBSeasy® products and services?	Cost for suppliers depend on negotiated contract and booked PBS product.
How to add "similar products"?	For every base article a supplier can also input cross selling items, which will be displayed in the PBSeasy® Shop on the product details page.
Where does the order end up?	The order recipient can be set up in MyPBSeasy® > Settings > Order transmission. Here they can state a standard order recipient (Email/FTP/SFTP or AS2) as well as an alternative recipient, in case standard recipient is not available.

How can I change my username?	Your username consists of a valid email address. If this has changed, the old account needs to be deletedand a new user account created. VAT input in Excel template	Please input without percentage sign (%)
I cannot see my uploaded images on the shop platform	Depending on how you provide your image files: Manual upload: make sure the names of your image files and the image names stated in the upload template do match exactly. Image links: if you provide image links in your upload template, please make sure they link directly to the product image and not to a general website.
Country of Origin	Make sure to use the correct country code and input in capital letters.
Upload images or template first?	If you upload your images manually, we recommend that you upload them first before uploading the product template.
I have uploaded my images first and then my template, but I am shown warnings that the images cannot be found.	The image upload does not run synchronous to the product upload. It always might take a bit longer for images to be matched to their product. Depending on the data volume it can take a while. Please check regularly. Also: check your upload protocols for Error messages and take appropriate action if needed.
Where do I find the latest upload template version?	You can download the template in "Catalog" > "Download format file"
How can I delete products?	Simply input the GTINs (EANs) of the products you want to delete into the first column of an Excel sheet. Upload under "Catalog" > "Delete Product".
What are the different prices on the shop platform?	 NET prices: are negotiated dealer prices. These are the prices negotiated between supplier and buyer. LP List prices: are your standard list prices (or catalogue prices) without discounts or rebate. RSP (NET): recommended selling prices without VAT. RSP (gross): recommended selling prices including VAT. OSD: Relevant for Danish buyers only Warehouse: Relevant for Danish buyers only
What is the minimum order quantity (MOQ)?	The minimum order quantity of your smallest selling unit with an EAN code (the smallest unit with a barcode on). For example, if your minimum order quantity is 50 pce, a buyer could not place orders for less than 50 pce through our platform.
What is the incremental order quantity (IOQ)?	The incremental order quantity defines the next higher amount (lot size) that can be ordered on top of the minimum quantity. Example: minimum order quantity is 50. If the lot size is 10



	(incremental value), the next amount the dealer can order is 60, then 70, 80 etc.
Which columns can be maintained in multiple languages?	See chapter 4 Excel Upload → "Catalog" → Uploading texts in multiple languages.
What is the product family?	For example: your product is a pen → then the product family could be "ballpoint pen" or "gel pen". The product family sorts an item into a specific category.
